## **Age Limit**:

- a) The age should be between 18 years to 25 years as on **23.02.2015** i.e. closing date of receipt of application.
- b) The above quoted upper age limit is relaxable in case of SC/ST/OBC/PWD/Ex-servicemen as permissible under the rules (5 years for SC/ST, 3 years for OBC, 10 years for PWD candidate, service + 3 years for Ex-servicemen).
- c) The crucial date for determining the age limit and qualification in each case will be the closing date for receipt of applications from candidates.

## GENERAL INSTRUCTIONS FOR THE ABOVE POSTS

- 1. The prescribed essential qualifications are minimum and enhanced qualification does not entail candidates to be called for written test/practical test/interview. Where the number of applications received in response to the advertisement are large and it will not be convenient or possible for the Institute to call all candidates for written test/practical test/interview, the Director, IVRI, Izatnagar reserves the right to fix the criteria for calling the candidates on the basis of qualification, experience etc. After screening the applications, the candidates will be called for written test/practical test and interview as the case may be.
- 2. These posts are non-government under the Indian Council of Agricultural Research, which will be governed by New Pension Scheme 2004 introduced by the Government of India with other service conditions mutatis-mutandis and as amended from time to time.
- 3. All posts are temporary but likely to continue. Candidates must ensure that they fulfill all the eligibility conditions for these posts with regard to qualifications and age.

Candidates belonging to SC/ST/Female candidate & PWD are exempted from payment of any fee.** No fee exemption is, however, allowed to the OBC candidates.
